#### COVID-19

Effective March 17, the Town of Bracebridge has closed all public offices indefinitely, including the Sportsplex and Arena, due to COVID-19. It's unclear how long current social distancing recommendations will be in place, and how the virus could affect the 2020 Tennis season. We will be guided by the Town as we move forward, and keep you informed. Presently, our plan is to proceed with the 2020 season as planned, but this could change quickly.

Opening day is tentatively scheduled for Saturday, May 2<sup>nd</sup> from 9 am – Noon at the Kelvin Grove Courts. Rain date is Saturday, May 9<sup>th</sup>.

## **Annual General Meeting/ Social**

The AGM/Social is scheduled for Thursday, August 27, 2020 at Kerr Park. We'll have a new format this year – a little tennis and social time, followed by the AGM and dinner. We've rented the Chalet for this event. Many thanks to Virginia Watts, who has volunteered to help me organize the AGM as this is a new format. #### **Kerr Park Update**

We are continuing to work with the Town on the potential relocation to Kerr Park. Our discussions are on hold while the Town deals with the COVID-19 crisis, and we'll keep you informed.

As many of you know, The Town of Bracebridge has developed comprehensive plans to replace the Town's 70-year-old Memorial Arena and 111-year-old Public Library with a much needed regional community hub, which, in addition to the arena, community hall and library replacements, will include a multi-sport field house (double sized gymnasium with track).

Many BTC members attended a community engagement session in early February to express the need for indoor tennis in Muskoka, include indoor courts as part of the multi-sport field house.
